REVISION OF RENT

LESSEE:

SFPP, L.P., a Delaware Limited Partnership 1100 Town and Country Road Orange, California 92868

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Walnut, Grayson, and Pacheco Creeks, Cordelia Slough, and the Carquinez Strait between Concord and West Sacramento in Contra Costa, Solano, and Yolo Counties.

AUTHORIZED USE:

Operation and maintenance of a 20-inch diameter petroleum products pipeline across all the waterways except the Carquinez Strait, which is a 14-inch diameter pipeline, extending from the SFPP Concord Station in Contra Costa County to the SFPP Sacramento Station in the city of West Sacramento, Yolo County.

LEASE TERM:

25 years, beginning October 20, 2003.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$9,475 per year to \$27,935 per year, effective October 20, 2013.

OTHER PERTINENT INFORMATION

- 1. Lessee has the right to use the upland adjoining a portion of the lease.
- 2. On November 13, 2003, the Commission issued a General Lease Right-of-Way Use to SFPP, L.P., a Delaware Limited Partnership, for the construction and maintenance of a 20-inch diameter petroleum products pipeline across each of the waterways except the Carquinez Strait, which is a 14-inch diameter pipeline. This pipeline is an interstate pipeline

regulated by the U.S. Department of Transportation. The last inspection was performed on January 26, 2012, and no violations have been reported at this time.

- 3. Staff conducted a rent review called for in the lease and recommends the rent be increased.
- 4. The staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).


