**REVISION OF RENT**

**LESSEE:**

Geysers Power Company, LLC  
4160 Dublin Boulevard, Suite 100  
Dublin, California 95113

**AREA, LAND TYPE, AND LOCATION:**

3.5 acres, more or less, of State lieu land in a portion of Section 33, Township 11 North, Range 8 West, MDM, near Middletown, Sonoma County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing unpaved access road, known as Pine Flat Road.

**LEASE TERM:**

25 years, beginning May 7, 1999.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease and recommends that rent be revised from \$100 per year to \$569 per year, effective May 7, 2014.

**OTHER PERTINENT INFORMATION:**

1. On June 14, 1999, the Commission authorized a General Lease – Right-of-Way Use to Geysers Power Company, LLC for an unpaved access road, known as Pine Flat Road. That lease will expire on May 6, 2024.
2. The access road is used by Geysers Power Company, LLC to access the Geysers power plant. The road was inspected in 2012. No violations have been reported.
3. There is an additional General Lease – Right-of-Way Use with Pacific Gas and Electric Company, Lease No. PRC 6794.2 for the same unpaved

access road to access its telecommunication site. PRC 6794.2 is also subject to a revision of rent and is being considered in Calendar Item #C99 of this Commission meeting.

4. The staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).

Authority: Public Resources Code section 21065 and California Code of Regulations, Title 14, sections 15060, subdivision (c)(3), and 15378.

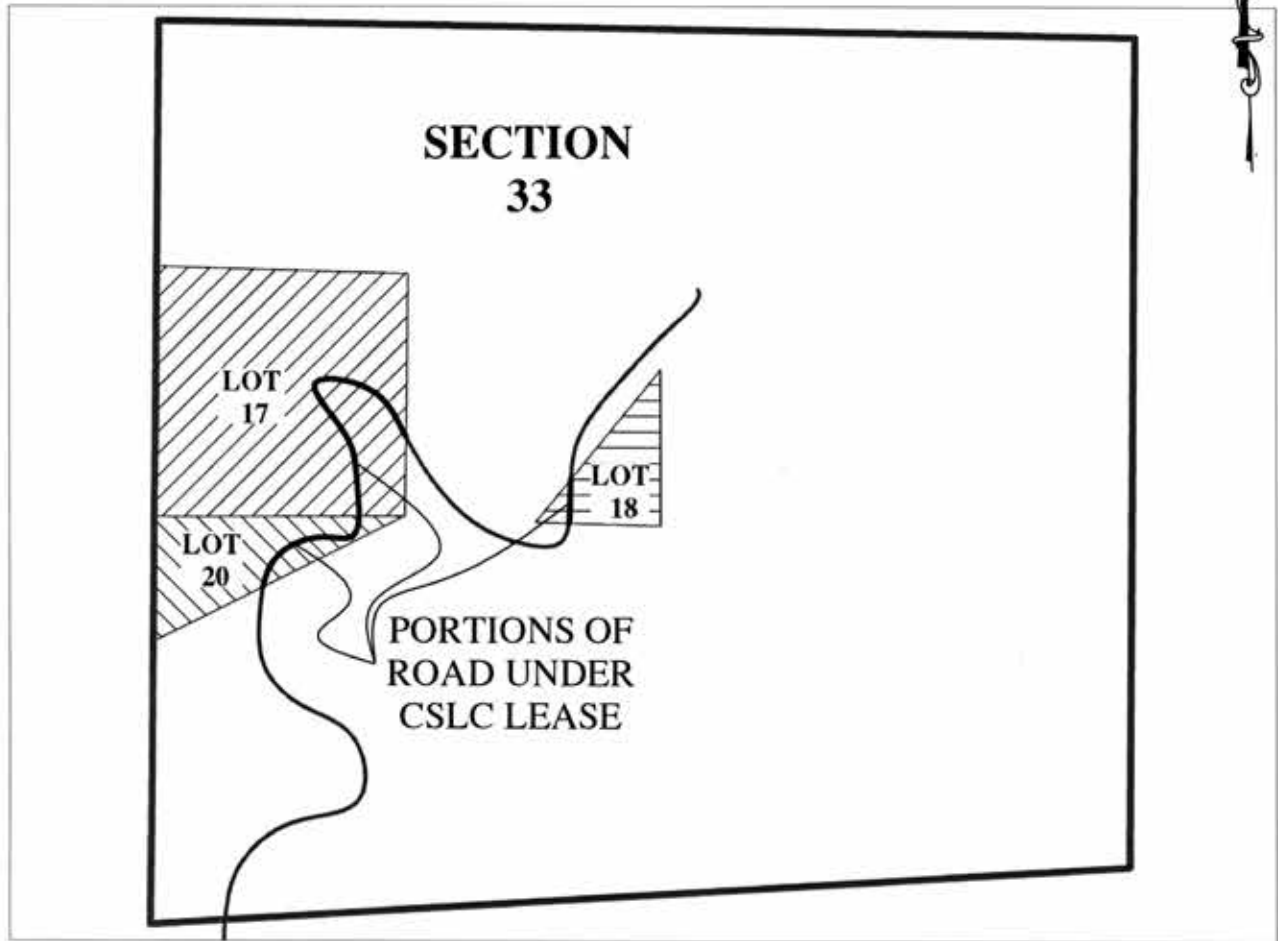
