### **REVISION OF RENT**

### LESSEE:

The Kissel Company dba Paradise Cove Land Company 28128 Pacific Coast Highway Malibu, CA 90265

### AREA, LAND TYPE, AND LOCATION:

0.2629 acre, more or less, of sovereign land in the Pacific Ocean, at Paradise Cove, Malibu, Los Angeles County.

### **AUTHORIZED USE:**

Continued use and maintenance of Paradise Cove Pier for commercial events, commercial film set location, fishing, and recreational use. Authorized uses specifically exclude the mooring, docking, storage, fueling, and launching of any vessels including personal watercraft from the pier.

### LEASE TERM:

10 years, beginning February 25, 2009.

#### **CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the minimum rent be revised from \$2,565 per year to \$3,565 per year, effective February 25, 2014.

### OTHER PERTINENT INFORMATION

- On June 28, 2010, the Commission authorized a ten-year General Lease

   Commercial Use with The Kissel Company, for the operation, use, and maintenance of the existing Paradise Cove Pier for commercial events, fishing, and recreational use; the lease commenced on February 25, 2009.




