ASSIGNMENT OF LEASE

LESSEE/ASSIGNOR:

Joseph F. Davi, Sr. and Laura L. Wright, as Trustees of the Davi Wright Revocable Trust Dated November 30, 2009

APPLICANT/ASSIGNEE:

Joshua Evans and Nicole Evans

AREA, LAND TYPE, AND LOCATION:

Sovereign land in Three-Mile Slough, adjacent to 18164 Sherman Island East Levee Road, near Rio Vista, Sacramento County.

AUTHORIZED USE:

Continued use and maintenance of an uncovered floating boat dock, landing, ramp, walkway, four pilings, and a two-pile dolphin.

LEASE TERM:

10 years, beginning August 1, 2012.

CONSIDERATION:

\$233 per year, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

OTHER PERTINENT INFORMATION:

- 1. Assignee owns the upland adjoining the lease premises.
- 2. On May 24, 2012, the Commission authorized a General Lease Recreational Use with Joseph F. Davi, Sr. and Laura L. Wright, as Trustees of The Davi Wright Revocable Trust dated November 30, 2009, for an uncovered floating boat dock, landing, ramp, walkway, four pilings, and a two-pile dolphin. That lease will expire on July 31, 2022. On July 14, 2014, the upland parcel was deeded to Joshua and Nicole Evans. The Applicants are now applying for an assignment of the lease.

3. The staff recommends that the Commission find that the subject lease assignment does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).

TOGETHER WITH a 10' use area.


EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark of said slough.







