**REVISION OF RENT**

**LESSEE:**

Tuscarora Gas Transmission Company  
201 W. North River Drive, Suite 505  
Spokane, WA 99201

**AREA, LAND TYPE, AND LOCATION:**

0.091 acre, more or less, of sovereign lands in the bed of the Pit River at five separate locations, near the city of Alturas, Modoc County.

**AUTHORIZED USE:**

Continued use and maintenance of three existing 20-inch diameter natural gas main pipelines (mainlines) and two 4-inch lateral lines.

**LEASE TERM:**

49 years, beginning June 1, 1995.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease and recommends that the rent be revised from \$500 per year to \$2,250 per year, effective June 1, 2015.

**OTHER PERTINENT INFORMATION:**

1. On May 3, 1995, the Commission authorized a General Lease – Right-of-Way Use with Tuscarora Gas Transmission Company. On October 17, 1995, the Commission authorized an amendment of lease to include two 4-inch diameter lateral lines, in the bed of the Pit River at two additional locations. The lease will expire on May 31, 2044.
2. The Lessee is in compliance with state and federal pipeline safety regulations and is monitored through a comprehensive inspection and enforcement program.

3. Staff conducted the rent review called for in the lease and recommends that the rent be increased to \$2,250 per year, effective June 1, 2015.
4. The staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).

Authority: Public Resources Code section 21065 and California Code of Regulations, Title 14, sections 15060, subdivision (c)(3), and 15378.

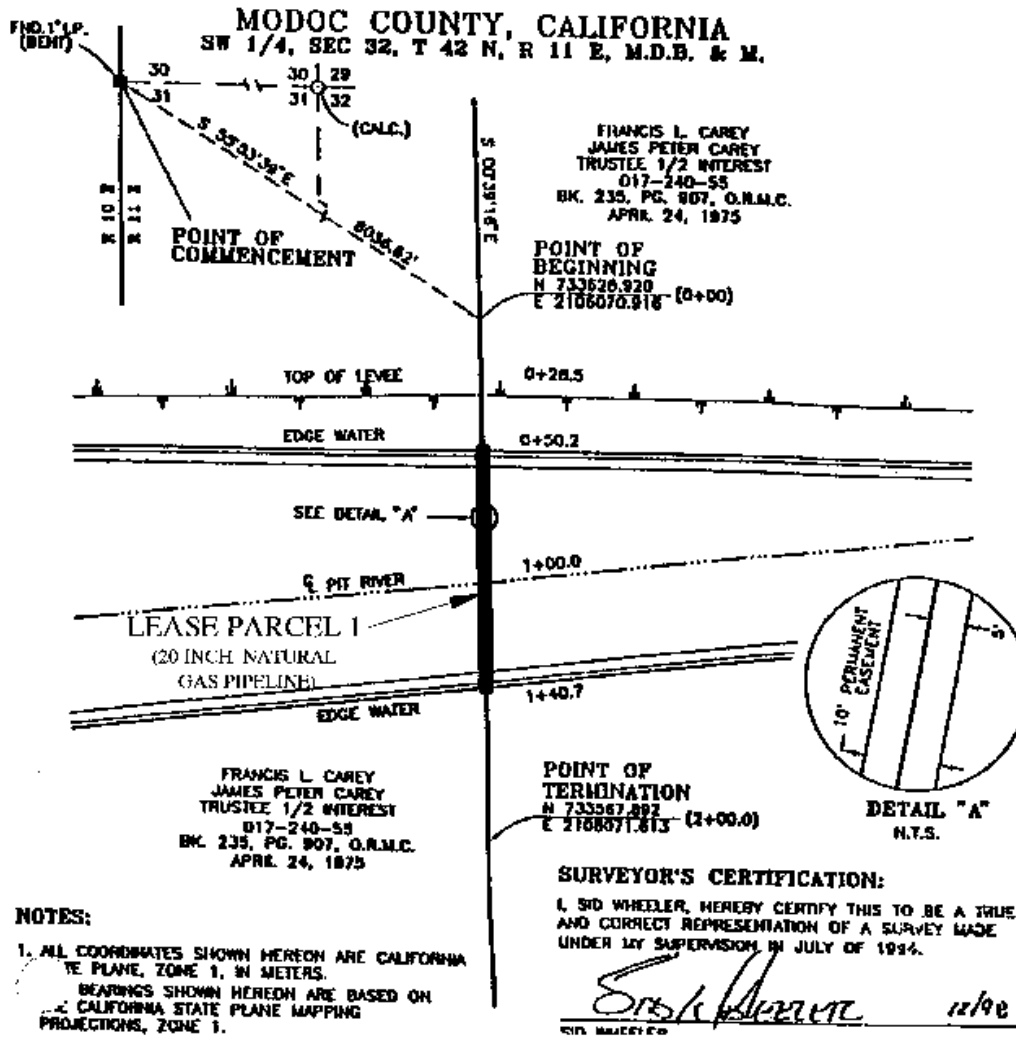

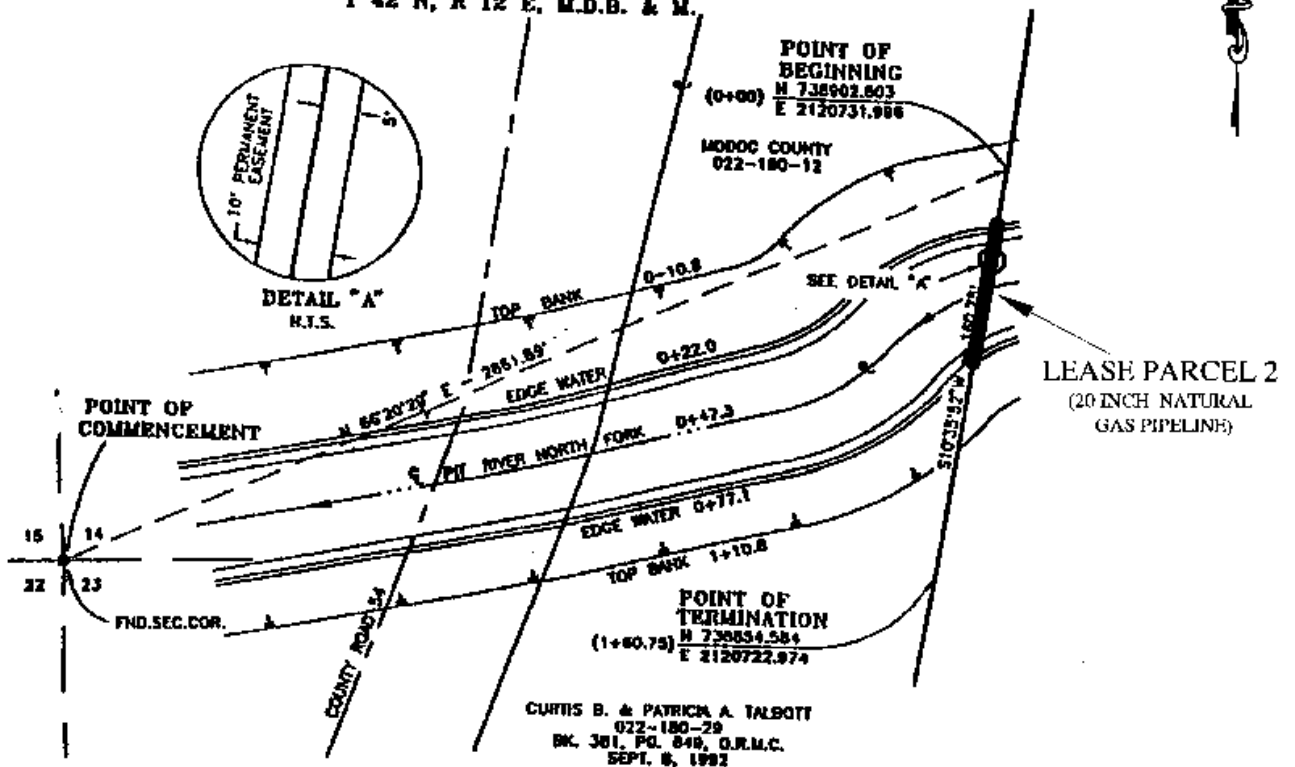

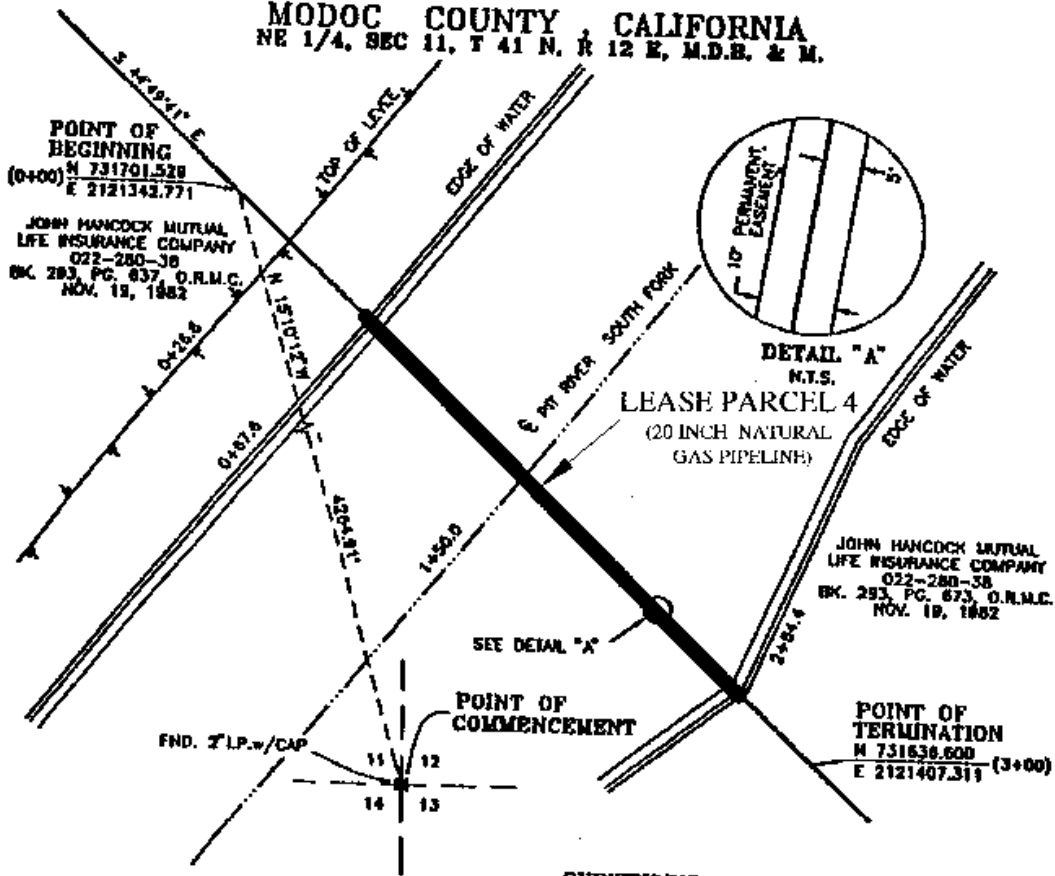

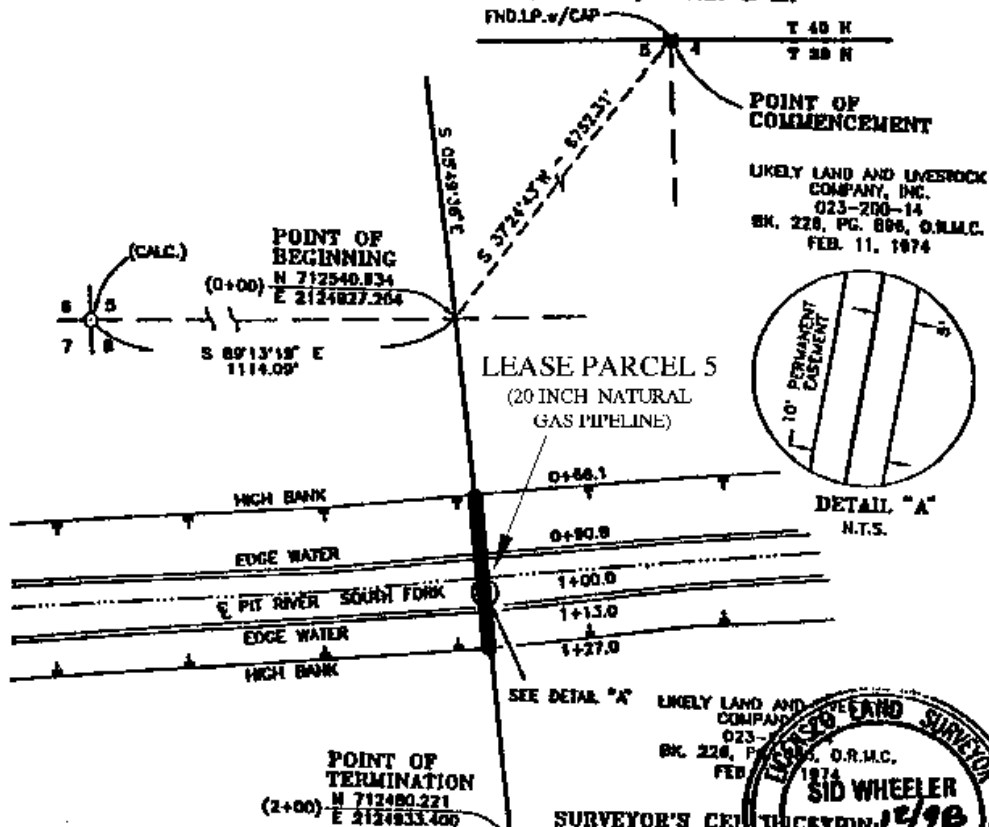

NW 1/4, SEC 8, T 39 N, R 13 E, M.D.B. & M.



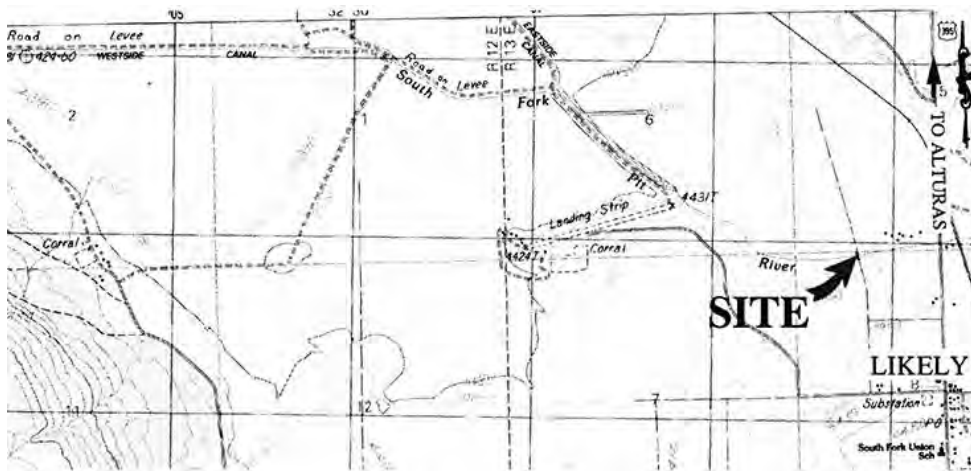
