# AREA, LAND TYPE, AND LOCATION:

Sovereign land in Corte Madera Creek, adjacent to 69 Greenbrae Boardwalk, near the city of Larkspur, Marin County.

# **AUTHORIZED USE:**

Use and maintenance of an existing uncovered floating boat dock, pilings, and gangway not previously authorized by the Commission.

# **LEASE TERM:**

20 years, beginning December 18, 2015.

### **CONSIDERATION:**

\$314 per year, with an annual Consumer Price Index adjustment.

# **SPECIFIC LEASE PROVISIONS:**

Liability insurance in an amount no less than \$1,000,000 per occurrence.

# OTHER PERTINENT INFORMATION:

- 1. Applicant owns the upland adjoining the lease premises.
- 2. On December 18, 2015, the Commission authorized a General Lease Recreational Use to Lee R. Miller and Dorothea E. Miller. Staff has since been made aware that the property was transferred to a trust. Therefore, staff is requesting Commission approval to correct the Applicant's name to Lee R. Miller and Dorothea E. Miller, as Trustors of the Miller Trust, dated January 1, 1992.


