REVISION OF RENT

LESSEE:

Pacific Gas and Electric Company

AREA, LAND TYPE, AND LOCATION:

0.54 acres, more or less, of sovereign land in the Sacramento River, in the cities of Sacramento and West Sacramento, Sacramento and Yolo counties.

AUTHORIZED USE:

Continued use and maintenance of a 20-inch-diameter welded steel natural gas pipeline.

LEASE TERM:

20 years, beginning February 9, 2006.

CONSIDERATION:

This lease provides that the Commission may modify the rent periodically during the lease term. Pursuant to this provision, staff conducted a review of the rent under this lease and recommends that rent be revised from \$3,125 per year to \$3,592 per year, effective February 9, 2018.

OTHER PERTINENT INFORMATION:

- 1. On February 9, 2006, the Commission authorized a General Lease Right-of-Way Use with Pacific Gas and Electric Company to construct, use, and maintain a natural gas pipeline (Item C37, February 9, 2006). On February 8, 2011 the Commission authorized a revision of rent from \$2,812 per year to \$3,125 per year, effective February 9, 2011 (Item C08, February 8, 2011). The lease will expire February 8, 2026.
- 2. Staff requested updated results of internal inspections or pressure tests made in the directionally drilled crossing section of the pipeline, and periodic inspection results of the cathodic protection system operation. Staff will review the reports upon receipt and based on the results take

any and all actions necessary to ensure the safety of the pipeline consistent with the Commission's jurisdiction and authority.

- 3. This action is consistent with Strategy 2.2 of the Commission's Strategic Plan to ensure timely receipt of revenues and royalties from the use and development of State lands and minerals.
- 4. Approving the revision of rent is not a project as defined by the California Environmental Quality Act because it is an administrative action that will not result in direct or indirect physical changes in the environment.


A. Site and Location Map
