GENERAL LEASE - PUBLIC AGENCY USE

APPLICANT:

City of Los Angeles Department of Water and Power

PROPOSED LEASE:

AREA. LAND TYPE. AND LOCATION:

State-owned school land within a portion of Section 36, Township 18 South, Range 36 East, and a portion of Section 36, Township 18 South, Range 37 East, MDM, near Owens Lake, Inyo County.

AUTHORIZED USE:

Installation, use, and maintenance of one camera and one Sensit.

LEASE TERM:

10 years, beginning June 21, 2018.

CONSIDERATION:

\$125 per year, with an annual Consumer Price Index adjustment.

STAFF ANALYSIS AND RECOMMENDATION:

Authority:

Public Resources Code sections 6005, 6216, 6217.5, 6501.1, 6503, and 8701; California Code of Regulations, title 2, sections 2000 and 2003.

State's Best Interests Analysis:

The City of Los Angeles Department of Water and Power (City or Applicant) has applied for a General Lease – Public Agency Use for the installation, use, and maintenance of one camera (for time-lapse photography) and one Sensit (air particle monitoring equipment) located on State-owned school land near Owens Lake. The proposed lease will allow the Applicant to monitor air quality conditions around Owens Lake as part of the Applicant's Owens Lake Dust Mitigation Control Program. The proposed lease is limited to a 10-year term, does not alienate the State's fee simple interest, and does not grant the Applicant exclusive rights to the lease premises. In addition, the camera and Sensit sites occupy a relatively small footprint.

The lease also requires the payment of annual rent, which generates revenue for the California State Teachers' Retirement System, consistent with the School Land Bank Act (Pub. Resources Code, § 8700, et seq.). For the reasons stated above, staff believes issuance of this lease is in the best interests of the State.

OTHER PERTINENT INFORMATION:

- 1. This action is consistent with Strategy 1.1 of the Commission's Strategic Plan to deliver the highest level of public health and safety in the protection, preservation, and responsible economic use of the lands and resources under the Commission's jurisdiction.
- 2. On March 27, 2018, staff provided the City a Letter of Non-Objection for the placement and operation of the camera and Sensit. The Letter of Non-Objection allowed the City to begin operation prior to consideration of the lease.
- 3. Staff recommends that the Commission find that this activity is exempt from the requirements of the California Environmental Quality Act (CEQA) as a categorically exempt project. The project is exempt under Class 6, Information Collection; California Code of Regulations, title 2, section 2905, subdivision (e)(5).

Authority: Public Resources Code section 21084 and California Code of Regulations, title 14, section 15300 and California Code of Regulations, title 2, section 2905.

CEQA FINDING:

Find that the activity is exempt from the requirements of CEQA pursuant to California Code of Regulations, title 14, section 15061 as a categorically exempt project, Class 6, Information Collection; California Code of Regulations, title 2, section 2905, subdivision (e)(5).

STATE'S BEST INTERESTS:

Find that the proposed lease is in the best interests of the State.

AUTHORIZATION:

Authorize issuance of a General Lease – Public Agency Use to the City of Los Angeles Department of Water and Power beginning June 21, 2018, for a term of 10 years, for the installation, use and maintenance of one camera and one Sensit, located on State-owned school land as described in Exhibit A and shown on Exhibit B (for reference purposes only) attached and by this reference made a part hereof; rent in the amount of \$125 per year, with an annual Consumer Price Index adjustment.




