NOTICE OF INTENT TO CONSIDER AN ADDENDUM TO A CERTIFIED FINAL ENVIRONMENTAL IMPACT REPORT

An Addendum has been prepared by the California State Lands Commission (CSLC), acting as a Responsible Agency under the California Environmental Quality Act (CEQA) (Pub. Resources Code, § 21000 et seq.), in connection with the Transfer of Daggett Street to the San Francisco Port Commission as described below. The Addendum to the 1000 16th Street Urban Mixed-Use Project (1000 16th Street Project) Final Environment Impact Report (EIR) was prepared pursuant to the requirements of the State CEQA Guidelines (Cal. Code Regs., tit. 14, § 15000 et seq.).

- Title: Transfer of Daggett Street (1000 16th Street Project)
- Location: Daggett Street is a portion of sovereign land, reserved to the State by the Legislature solely for street purposes. It is trapezoidal in shape and contains approximately 37,949 square feet. The parcel diagonally crosses between Blocks 3833 and 3834 and intersects the north side of 16th Street and the west side of 7th Street in San Francisco, California.
- **Description**: CSLC consideration of a termination of the public trust and the transfer of the Daggett Street property from the San Francisco Port Commission to the City of San Francisco, prior to implementation of the 1000 16th Street Project.
